TYPES OF DATA WE COLLECT

We may collect the following types of personal data: contact information (name, surname, email address, phone number, jmbg), transaction data, audio and video recordings, device data (IP address, device type, operating system, browser you use), behavioral data (pages visited on our site, time spent on pages, dates and times of access).

METHOD OF DATA COLLECTION

Data may be collected in the following ways:

Directly from you: When you fill out the contact form on our website, sign up for our newsletter, application form or get in touch with us.

Automatic: When you visit the site, we use cookies and other tracking technologies.

From third parties: The collection of data may come from third parties such as analytics providers (e.g. Google Analytics) or through integrations with social networks.

PURPOSE OF PROCESSING PERSONAL DATA

We use the collected data for the following purposes:

USE OF COOKIES

SHARING DATA WITH THIRD PARTIES

Right to data portability: you can request that your data be transferred to a third party of your choice.

Right to object: You have the right to object to the processing of your data for marketing purposes or on the basis of a legitimate interest.

DATA RETENTION
